The minutes from the last board meeting along with the financial reports were read and reviewed and with no changes they were approved. Cheryl Lee, MPS Pool Manager, gave an update on needs for the pool before opening for next season. These needs will be done in a timely manner. The board approved the donation of two Limited Pool Memberships. These will be used in a silent auction with advertising for our pool. The board approved the increase cost of Limited Pool Memberships to \$300.00 for a family of 5 and \$60.00 for each additional family member. Sara Stennett will email the board with her cost search results on new tables and chairs for the clubhouse. The meeting adjourned at 8:30.

POOL AND CLUBHOUSE RENTAL

Renting the pool and clubhouse only costs homeowner's \$50.00 and for non-homeowner's it is just \$175.00. The cost for lifeguards to work pool parties is \$12.50 an hour. There is a two-hour, two lifeguard minimum for pool parties. The deposit is \$350.00 for these rentals. The deposit will be returned to the renter if everything is left like it was found. The rental fees are never deposited until after the event in case of a cancellation.
